


# **OVERVIEW**




Figure 1. Internal Views of the Enclosure

The PairGain® PG-Flex® FRE-860, FRE-865, FRE-867, and FRE-868 Remote Terminal (RT) Enclosures (see Figure 1) conveniently mount RT line units (LU) and channel units (CU). The RT Enclosures provide termination points for subscriber circuits, HDSL, auxiliary power, and metallic bypass pairs.

The units described by this document get power from the HDSL lines connected to the COT Shelf. For each doubler installed between the COT Shelf and RT Enclosure, two additional power pairs are required from the COT Shelf to the RT Enclosure.

# **INSTALLATION AND TURN-UP**

The installation of an RT Enclosure involves the following procedures:

- mounting the RT Enclosure
- wiring the RT Enclosure
- turn-up and testing
- closing the housing



Be careful when working with telephone circuits. Dangerous voltages can be present. It is unsafe to install telephone wiring during a lightning storm.

All wiring external to the product should follow the local wiring codes.

Always treat the HDSL pairs as if they were live with high voltage present. Use caution when installing HDSL pairs that are already connected to a COLU, because dangerous voltages are present on the HDSL pairs.

The COLU, unless previously disabled by means of Craft provisioning, periodically attempts to power up the RT Enclosure by applying +/-130 Vdc to the HDSL pairs.

### INSTALLING THE FRE-860 RT ENCLOSURE

The FRE-860 RT Enclosure has external mounting flanges with tapped holes for #10-machine screws for pedestal mounting.

- 1 Remove horizontal crossbars from the UP10900 pedestal prior to mounting the FRE-860.




Figure 2. FRE-860 RT Enclosure and Termination Panel

- 2 Attach the RT Enclosure to the pedestal frame, using the mounting flanges (see Figure 2). Use the mounting hardware provided with the RT Enclosure. Follow local practices to ensure a secure mounting.

4 Install 5-pin protector plugs for all connected pairs.

## INSTALLING THE FRE-865 AND FRE-867 RT ENCLOSURES




Figure 3. FRE-865 and FRE-867 RT Enclosures

The FRE-865 and FRE-867 RT Enclosures have external mounting tabs with clearance holes for  $\frac{3}{8}$ -inch bolts (see Figure 3).

1 When mounting to a pole using the Pole Mounting Kit (150-2397-0x), ensure the kit and FRE-86x are fully installed before connecting the cables. The customer must provide the appropriate mounting hardware. Follow local practices to ensure a secure mounting. The FRE-867 has lifting tabs to facilitate the mounting of the enclosure.

2 Connect the HDSL cable stub as listed in Table 3. The FRE-865 contains only one system (designated as System 1), the FRE-867 has two systems, System 1 and System 2.

3 Connect the Subscriber cable stub as listed in Table 4. For the FRE-867, the System 1 subscriber lines are in the blue binder group, and System 2 subscriber lines are in the orange binder group.

4 Install 5-pin protector plugs for all connected pairs.

## INSTALLING THE FRE-868 RT ENCLOSURE

The FRE-868 RT Enclosure has four mounting slots for #10 wood screws for indoor wall mounting.

1 Attach the RT Enclosure to the wall, using the mounting slots. Follow local practices to ensure a secure mounting.




Figure 4. FRE-868 RT Enclosure

- 2 Connect the HDSL pairs to the HDSL Terminations (see Figure 4).
- 3 Connect a female Amphenol-ended subscriber cable to the subscriber line connector (not supplied) (see Figure 4).
- 4 Terminate the connector as shown in Table 5.
- 5 FRE-868 List 3 and List 4 provide for HDSL protection. Install 5-pin protector plugs on all connected pairs.

### **CHASSIS GROUND WIRING**




Figure 5. Installing the Ground Wire

To install the chassis ground wire, perform the following steps for the appropriate unit. The location for the grounds for the different models are shown in Figure 5.



Use 6 AWG wire to ensure a good ground connection to the FRE-86x.

- 1 For the FRE-860, FRE-865, and FRE-867, List 1 and List 1A, route the chassis ground wire through the small hole in the strain relief on the bottom of the RT Enclosure.
- 2 For the FRE-868, List 1, List 2, List 3, and List 4, route the chassis ground wire through the hole provided on the right side of the RT Enclosure.
- 3 For all models, connect one end of the chassis ground wire to the grounding lug.
- 4 Connect the other end of the chassis ground wire to a suitable ground termination point (ground rod or cold water pipe).
- 5 Tighten the strain relief around the wire.

#### CABLING VERIFICATION



Perform the following verifications before inserting any cards in the RT Enclosure or the COT Shelf.

Verify the following connections:

- 1 Visually ensure that the ground wire is tightly secured to the grounding post inside the RT Enclosure and at the ground termination point.
- 2 Visually verify that the HDSL lines are terminated correctly and with the correct orientation.
- **3** Verify that the HDSL lines are dry.
  - **a** Verify 0 Vdc between the Tip and Ring, Tip and Ground, and Ring and Ground of each of the HDSL pairs terminated at the RT Enclosure.
  - **b** Verify greater than 100 k $\Omega$  resistance between Tip and Ground, and Ring and Ground for each of the HDSL pairs terminated at the RT Enclosure.

### **TURN-UP AND TESTING**



To prevent condensation, power the RT Enclosures soon after installation. It is sufficient to power up only the LUs.

Refer to the COLU Technical Practice or RTLU Technical Practice for complete COT and RT turn-up and testing procedures.

## **CLOSE THE HOUSING**

- 1 If you have not already done so, close the LU Access doors.
- 2 Close the RT Enclosure housing cover and use the 216 tool to secure the door.
- 3 The installation is complete.

## **TROUBLESHOOTING**

Refer to the COLU Technical Practice or RTLU Technical Practice for complete COT and RT troubleshooting procedures.
